Dear Member,

You are well aware that Punjab Revenue Authority, Government of Punjab has imposed a sales tax on services by Architects. A number of architects/architectural firms have already received such notices from the Punjab Revenue Authority (PRA). The Institute of Architects Pakistan, (Lahore Chapter) has taken up this matter and the Lahore High Court Lahore has issued a restraining order/status-quo in favour of IAP Lahore Chapter.

In this scenario, Punjab Revenue Authority, Government of Punjab, Lahore has asked the IAP to provide a list of bonafide members of the Institute of Architects (Lahore Chapter). The list is being finalized and will be forward to the quarter concerned by 7th August 2015. Only BONAFIDE members will be included in the list being sent to PRA.

Executive Committee Members of IAP-LC had a meeting with the Legal Advisor, pleading the case in the court on 25.07.2015 in IAP Secretariat. He has advised that only "bonafide members" of IAP-LC (fees fully paid up) will benefit from the High Court Orders and any relief granted by the courts or any other authority in future. You are therefore, requested in your own interest to please clear all your dues at the earliest.
